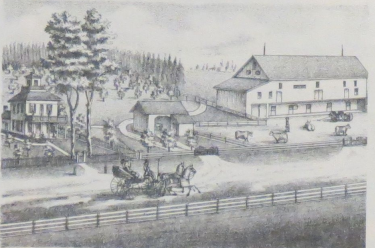


# MAP OF BROOKVILLE TOWNSHIP

T. P. 24 RANGE No. 7 E. OF 4 P. M.



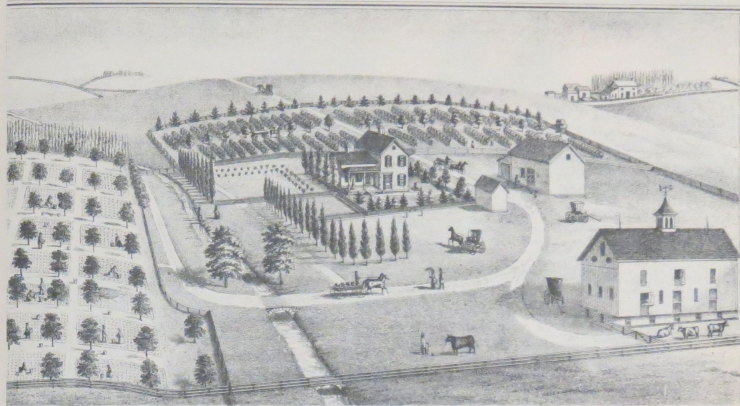

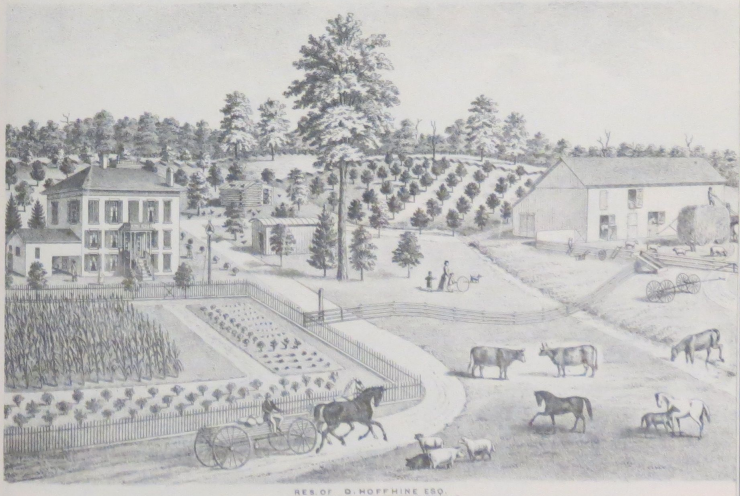

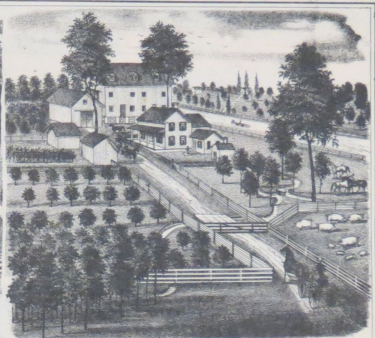

# MAP OF FORRESTON TOWNSHIP

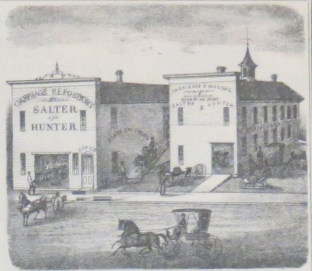
