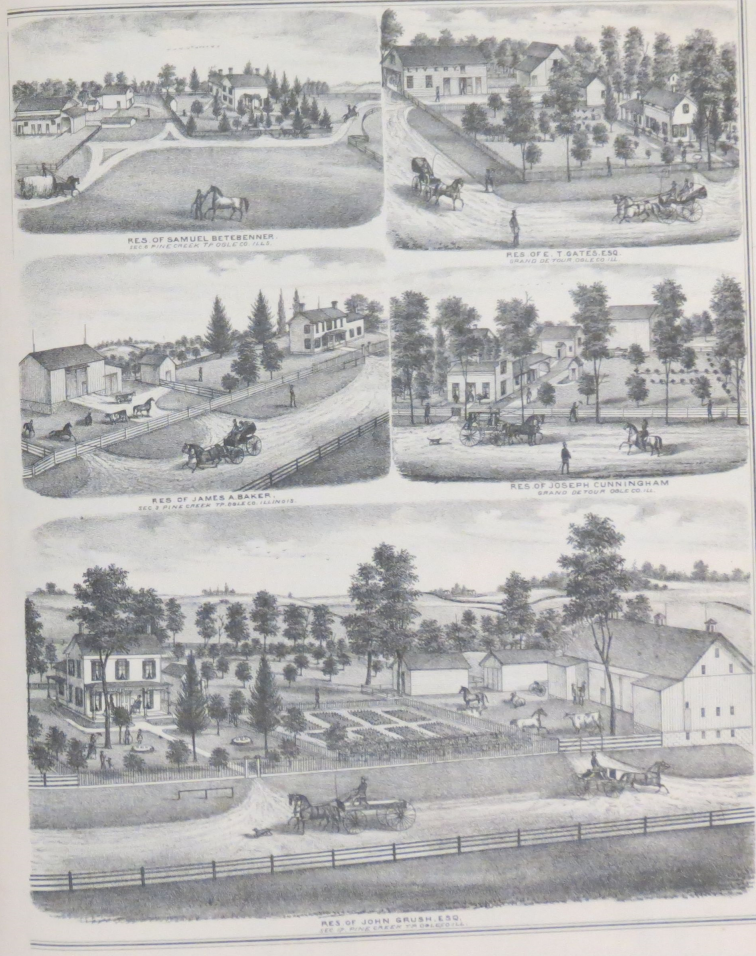
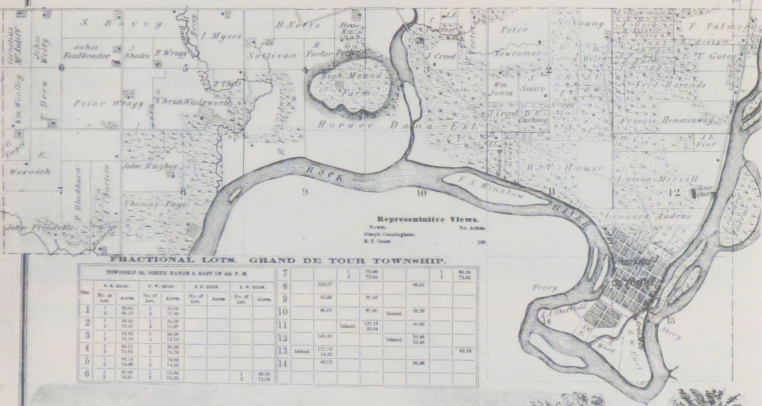


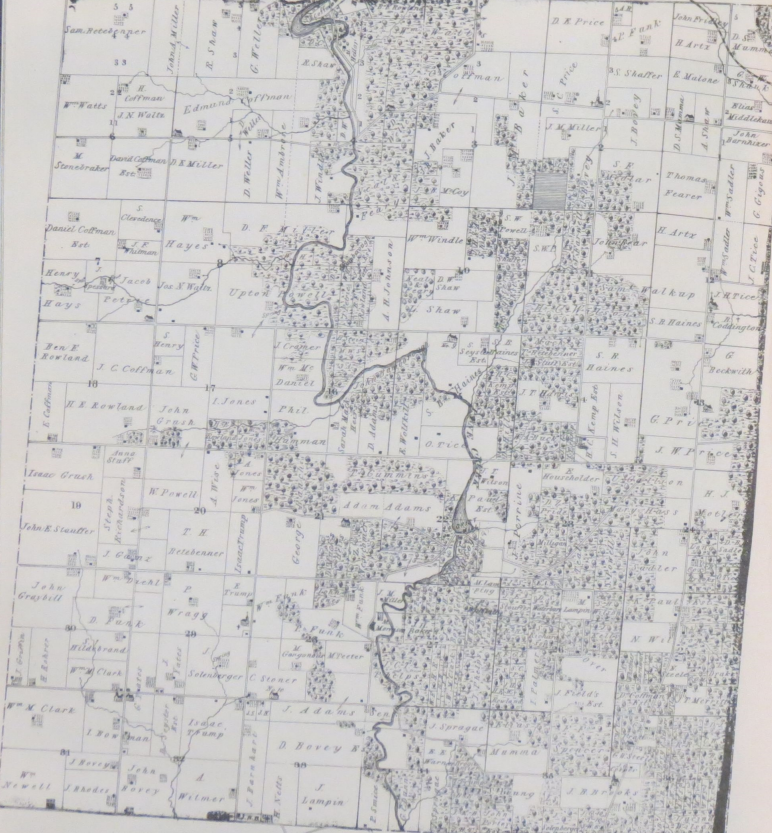
MAP OF GRAND DE TOUR TOWNSHIP

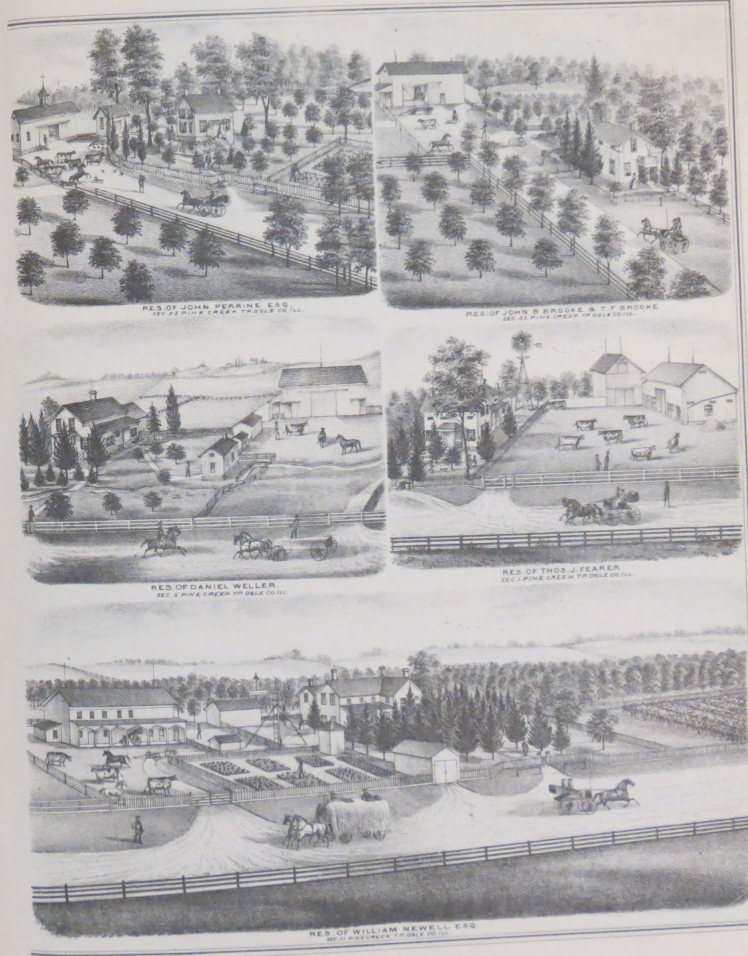
MAP OF PINE CREEK TOWNSHIP

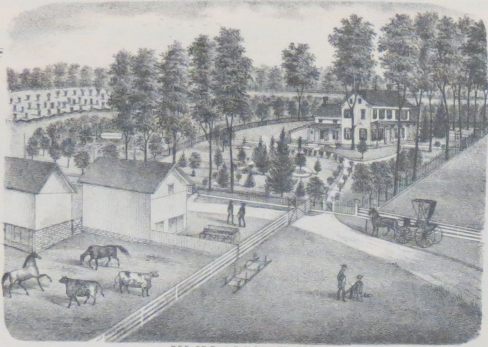

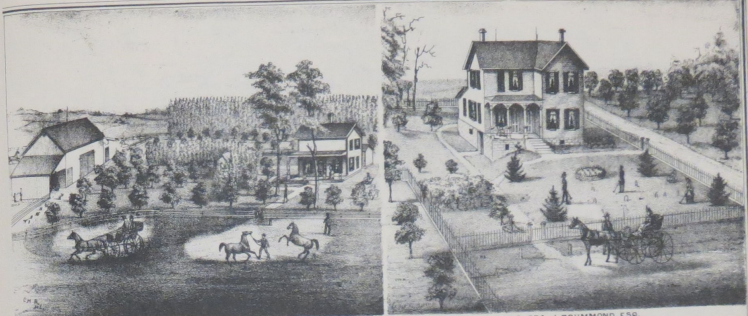


MAP OF LAFAYETTE TOWNSHIP
